2007 MILFOIL GRANT - Shelley Vincent

- The Milfoil Committee is working on the preparation of the 2007 ADA Milfoil Grant Application.
- Education: This year the Committee is going to include in the application a request for textbooks for understanding invasive aquatic species for Mrs. Vans who teaches 5th grade at Southside School.
- Lake Host Program this year the Committee is including in the grant request money for improvements at the F&G boat launch area at the north end of the lake to provide support for a hook-up for a summer Lake Host at this site. These improvements would include an electrical service, reactivating the current well to provide water and installing a holding tank for an RV.
